THE SACRAMENT OF EUCHARIST

The Eucharist is "the source and summit of the Christian life.

For in the blessed Eucharist is contained the whole spiritual good of the Church, namely Christ himself, our Pasch."

We carry out the Lord's command of "Do this in remembrance of me" by celebrating the memorial of His sacrifice. In so doing, we offer the the Father what he has himself given us: the gifts of his creation, bread and wine which, by the power of the Holy Spirit and by the words of Christ, have become the body and blood of Christ. Christ is thus really and mysteriously made present. We must therefore consider the Eucharist as: thanksgiving and praise to the Father; the sacrificial memorial of Christ and his Body; the presence of Christ by the power of his word and of his Spirit.

Holy Communion augments our union with Christ. Holy Communion separates us from sin.

To prepare for worthy reception of Holy Eucharist, the faithful should observe the fast required in their Church. Bodily demeanor (gestures, clothing) ought to convey the respect, solemnity, and joy of this moment when Christ becomes our guest.

One of the significant changes for the faithful in the *Code of Canon Law*, which was promulgated in 1983, was the permission to receive Holy Communion more than once per day. C917 A person who has received the Most Holy Eucharist may receive it again on the same day a second time only during the celebration of the Eucharist in which the person participates, with due regard for the prescription of can. 921 part 2.
